Terms and conditions

Everyone who posts a picture of their Happy Shoes on Twitter, Facebook or Instagram using #HappyShoesday, #Roadsafety and @livingstreets on Tuesday 21st May 2019 & Tuesday 1st October 2019 will be entered into the prize draw for 1 x £50 Book Voucher.

No other means of entry will be accepted.

Free Entry:

There is no charge for entering the prize draw, no money is exchanged.

Number of Entries Allowed:

Unlimited.

Entry:

Entrants will be submitted for entry to the prize draw via social media post.

Closing Date:

The closing date for entry to the prize draw is 5pm on 21st May 2019 & Tuesday 1st October 2019. The prize draw will take place within 4 weeks of the closing date of the prize draw.

Prizes:
