

# Living Streets' #WalkThisMay pledge

## Terms and conditions

The prize draw is managed by Living Streets (The Pedestrians' Association), herein known as Living Streets. Registered Charity No. 1108448 (England and Wales) and SC039808 (Scotland), Company Limited by Guarantee (England & Wales), Company Registration No. 05368409.

Anyone from the United Kingdom is eligible to enter into the prize draw, which runs from 22 April – 31 May 2021 inclusive.

There will be three winners selected at random. The first person drawn will win £200 in shopping vouchers, two runners up will win £50 shopping vouchers.
